Definition of Homeless Child or Youth,

as Defined by 42 U.S.C. Section 11434a, the McKinney-Vento

Homeless Assistance Act

The term "homeless children and youths"—

- A) means individuals who lack a fixed, regular, and adequate nighttime residence
- B) includes—
 - (i) children and youths who are sharing the housing of other persons due to loss of housing, economic hardship, or a similar reason; are living in motels, hotels, trailer parks, or camping grounds due to the lack of alternative adequate accommodations; are living in emergency or transitional shelters; or are abandoned in hospitals;
 - (ii)children and youths who have a primary nighttime residence that is a public or private place not designed for or ordinarily used as a regular sleeping accommodation for human beings;
 - (iii) children and youths who are living in cars, parks, public spaces, abandoned buildings, substandard housing, bus or train stations, or similar settings; and
 - (iv) migratory children who qualify as homeless for the purposes of this part because the children are living in circumstances described in clauses (i) through (iii) above.

Birth Certificates

Effective September 1, 2019: Texas Health and Safety Code §191.0049: State and Local Registrars and County Clerks shall provide birth records (birth certificates) to homeless children and youths as defined by 42 U.S.C. Section 11434a, the McKinney-Vento Homeless Assistance Act, without fee or parental consent.

Texas Identification Cards and Driver's Licenses

Effective September 1, 2019: Texas Transportation Code §521.1015 states that a homeless child or youth, as defined by 42 U.S.C. Section 11434a, the McKinney-Vento Homeless Assistance Act, may provide a copy of their birth certificate as proof of their identity and U.S. citizenship, provide a letter from one of the entities listed on this form, certifying the child or youth is homeless and does not have a residence or domicile, and obtain a personal identification certificate (Texas ID) without the signature, presence of or permission from the parent or guardian of the child or youth and be exempt from payment of the ID card fee. Texas Transportation Code §521.1811 waives the fee for a driver's license for a homeless youth.
